I further covenant and agree not to sue, attach, or prosecute Safari Island/Rink Management, its elected officials, or the Safari Island General Manager. I understand that, by signing this agreement, I am giving up legal rights that may be available to me. Nothing in this agreement shall affect or diminish any immunity or tort liability limitation applicable to Safari Island/Rink Management, its elected officials, employees or the Safari Island General Manager. The releases, indemnifications and other provisions of this paragraph shall survive the termination of my membership and this agreement.

Batting Cage Rules & Procedures General Guidelines

1. Must be accompanied by a Parent/Adult Guardian.
2. You must reserve a spot prior to starting.
3. All participants must sign a waiver before starting the activity. Those individuals under 18 must have a signed form by an adult.
4. The extension chord(s) for the pitching machine(s) must be returned to the front desk after use. A driver's license or major credit card will be held until returned.
5. All balls must be picked up, placed in designated containers and returned to the front desk when finished. A driver's license or major credit card will be held until returned.
6. No Climbing on the cage structure.
7. No hanging on the nets. No hanging items/equipment from the netting. Nets must remain touching the floor to operate correctly.
8. No modification to the cage structure, equipment or netting shall take place once SI has placed the equipment. Alternation to netting or structure may cause injury and/or death.
9. Only designated balls and equipment will be used in the batting cages. Keep designated balls in the cages.
10. One person per station for hitting purposes.
11. Safari Island/Rink Management reserves the right to make alterations to rules and/or procedures and close the activity area for other events, rentals and safety purposes.
12. Cancellation Policy: Rentals cancelled within 2 hours of the rental will forfeit 100% of the rental fee. Rentals cancelled with 48 hours will forfeit 50% of the rental fee. The cancellation policy applies to reducing the rental cage from 2 cages to 1 cage.
13. Additional \$50 charge and/or suspension from use will be assessed for not following the rules or repeat actions.

Baseball/Softball Specific

1. Pitching machines are intended for use by operators who are at least 18 years of age and who have been instructed in their use by reading thoroughly and understanding all instructions, safety rules, machine labels contained in the manual. The manual is located in the pocket on the machine. Misuse may result in bodily harm, dismemberment and/or death.
2. One person at a time in the designated batting area.
3. One person allowed at the pitching mound/machine at a time.
4. Only the balls provided are accepted in the batting cage.
5. Batting helmets must be worn at all times by all persons in the cage area.
6. Batting helmets provided upon request. Participants may provide their own batting helmets. These helmets must be in good condition and for use of the intended purpose.
7. Official bats must be used at all times. No wood bats allowed or other hitting devices. Bats will not be provided.
8. With the exception of the pitcher/operator and batter, all other participants must wait on the outside of the batting cage netting area. Individuals waiting to use the cage may use the additional space to play catch. Please do not use the pitching machine balls for catch.

Golf Specific

1. One person hitting per tee mat.
2. You must bring your own clubs.
3. Participants must hit from the designated tee mat. The tee mat may not be moved or altered from intended space.
4. Participants must use the designated balls provided.
5. Golf etiquette applies. Please no additional noises.
6. All Players must wait for players to finish before "shagging balls." "Shagging balls" should be done at the same time. All players must respect the play of others.
